### **Junior Firefighter Recruitment Grant**

The Lancaster County Firefighter's Education Foundation (LCFEF) is a 501,C-3 non-profit dedicated to the education and training of the public, firefighter's, and emergency medical personnel in Lancaster County. The LCFEF was created and sponsored by the Lancaster County Firemen's Association (LCFA).

The LCFEF is offering a limited grant opportunity to Emergency Services Organizations (ESO) that are members in good standing of the LCFA. Whereas, it has come to the attention of the LCFA that some member ESOs conduct Junior Firefighter programs to educate and recruit young members of their communities to become involved in the volunteer fire service, specifically as a Junior Firefighter. The LCFEF will accept applications from LCFA member ESOs for limited partial reimbursement of their expenses for such a program. ESOs may only submit one application per calendar year. The amount of reimbursement granted will be based on the number of persons completing the program and the total number of ESO applications received.

Complete the attached application for consideration. If the program is sponsored by more than one LCFA member ESO, only one application will be considered per program.
